

2022

For the 2022 Edition of *The Best Lawyers in America*[®], 1290 lawyers in the Connecticut region listed in Best Lawyers were contacted by telephone, email, and/or fax. Each one received a ballot tailored to his or her legal specialty and location. Of that group, 254 ballots were returned (19.69%). The total pool of candidates included 828 previously-listed Connecticut lawyers and 413 new nominees. Overall, 17413 votes were cast. Solely on the basis of a tabulation of these votes, 875 lawyers from Connecticut were selected for inclusion in the 2022 Edition of Best Lawyers.

For the 2022 Edition of *Best Lawyers: Ones to Watch in America*, 257 lawyers in the Connecticut region nominated in Best Lawyers: Ones to Watch were contacted by telephone, email, and/or fax. Each one received a ballot tailored to his or her legal specialty and location. Of that group, 69 ballots were returned (26.85%). The total pool of candidates included 828 previously-listed Connecticut lawyers and 80 new nominees. Overall, 3805 votes were cast. Solely on the basis of a tabulation of these votes, 173 lawyers from Connecticut were selected for inclusion in the 2022 Edition of *Best Lawyers: Ones to Watch in America*.

2021

For the 2021 Edition of The Best Lawyers in America, 1528 lawyers in the Connecticut region listed in Best Lawyers were contacted by telephone, email, and/or fax. Each one received a ballot tailored to his or her legal specialty and location. Of that group, 285 ballots were returned (18.65%). The total pool of candidates included 763 previously-listed Connecticut lawyers and 549 new nominees. Overall, 18314 votes were cast. Solely on the basis of a tabulation of these votes, 1043 lawyers from Connecticut were selected for inclusion in the 2021 Edition of Best Lawyers.

2020

For the 2020 Edition of The Best Lawyers in America, 1353 lawyers in the Connecticut region listed in Best Lawyers were contacted by telephone, email, and/or fax. Each one received a ballot tailored to his or her legal specialty and location. Of that group, 268 ballots were returned (19.81%). The total pool of candidates included 747 previously-listed Connecticut lawyers and 564 new nominees. Overall, 6521 votes were cast. Solely on the basis of a tabulation of these votes, 785 lawyers from Connecticut were selected for inclusion in the 2020 Edition of Best Lawyers.

2019

For the 2019 Edition of The Best Lawyers in America, 1298 lawyers in the Connecticut region listed in Best Lawyers were contacted by telephone, email, and/or fax. Each one received a ballot tailored to his or her legal specialty and location. Of that group, 251 ballots were returned (19.34%). The total pool of candidates included 732 previously-listed Connecticut lawyers and 519 new nominees. Overall, 6610 votes were cast. Solely on the basis of a tabulation of these votes, 767 lawyers from Connecticut were selected for inclusion in the 2019 Edition of Best Lawyers.

2018

For the 2018 Edition of The Best Lawyers in America, 1171 lawyers in the Connecticut region listed in Best Lawyers were contacted by telephone, email, and/or fax. Each one received a ballot tailored to his or her legal specialty and location. Of that group, 206 ballots were returned (17.59%). The total pool of candidates included 660 previously-listed Connecticut lawyers and 432 new nominees. Overall, 8089 votes were cast. Solely on the basis of a tabulation of these votes, 764 lawyers from Connecticut were selected for inclusion in the 2018 Edition of Best Lawyers.

2017

For the 23rd Edition (2017) of The Best Lawyers in America, 1074 lawyers in the Connecticut region listed in Best Lawyers were contacted by telephone, email, and/or fax. Each one received a ballot tailored to his or her legal specialty and location. Of that group, 178 ballots were returned (17%). The total pool of

candidates included 647 previously-listed Connecticut lawyers and 398 new nominees. Overall, 6,280 votes were cast. Solely on the basis of a tabulation of these votes, 686 lawyers from Connecticut were selected for inclusion in the 2017 Edition of Best Lawyers.

2016

For the 22nd Edition (2016) of The Best Lawyers in America, 651 lawyers in the Connecticut region listed in Best Lawyers were contacted by telephone, email, and/or fax. Each one received a ballot tailored to his or her legal specialty and location. Of that group, 143 ballots were returned (22%). The total pool of candidates included 635 previously-listed Connecticut lawyers and 387 new nominees. Overall, 10,478 votes were cast. Solely on the basis of a tabulation of these votes, 676 lawyers from Connecticut were selected for inclusion in the 2016 Edition of Best Lawyers.

2015

For the 21st Edition (2015) of The Best Lawyers in America, 642 lawyers in the Connecticut region listed in Best Lawyers were contacted by telephone, email, and/or fax. Each one received a ballot tailored to his or her legal specialty and location. Of that group, 121 ballots were returned (19%). The total pool of candidates included 1146 previously listed Connecticut lawyers and 718 new nominees. Overall, 96,426 votes were cast. Solely on the basis of a tabulation of these votes, 654 lawyers from Connecticut were selected for inclusion in the 2015 Edition of Best Lawyers.

2014

For the 2014 (20th) Edition of The Best Lawyers in America, 637 lawyers in the Connecticut region listed in Best Lawyers were contacted by telephone, email, and/or fax. Each one received a ballot tailored to his or her legal specialty and location. Of that group, 489 ballots were returned (77%). The total pool of candidates included 647 previously listed Connecticut lawyers and 437 new nominees. Overall, 49,308 votes were cast. Solely on the basis of a tabulation of these votes, 646 lawyers were selected for inclusion in the 2014 Edition of Best Lawyers.

2013

For the 2013 (19th) edition of The Best Lawyers in America, 516 lawyers in the Connecticut region listed in Best Lawyers were contacted by telephone, email, and/or fax. Each one received a ballot tailored to his or her legal specialty and location. Of that group, 373 ballots were returned (72%). The total pool of candidates included 553 previously-listed Connecticut lawyers and 244 new nominees. Overall, 35,951 votes were cast. Solely on the basis of a tabulation of these votes, 651 lawyers were selected for inclusion in the 2013 edition of Best Lawyers.

2012

For the 2012 (18th) edition of The Best Lawyers in America, 520 lawyers in the Connecticut region listed in Best Lawyers were contacted by telephone, email, and/or fax. Each one received a ballot tailored to his or her legal specialty and location. Of that group, 375 ballots were returned (72%). The total pool of candidates included 520 previously-listed Connecticut lawyers and 294 new nominees. Overall, 35,422 votes were cast. Solely on the basis of a tabulation of these votes, 561 lawyers were selected for inclusion in the 2012 edition of Best Lawyer.
