



### 2021

For the 11th Edition (2021) of "Best Law Firms," 1,352 ballots were sent to lawyers in the Connecticut region, and 285 firms were nominated. A total of 4,653 Connecticut voters gave feedback on firm work and provided 10,607 individual firm evaluations.

### 2020

For the 10th Edition (2020) of "Best Law Firms," 1,352 ballots were sent to lawyers in the Connecticut region, and 258 firms were nominated. A total of 5,011 Connecticut voters gave feedback on firm work and provided 11,608 individual firm evaluations.

### 2019

For the Ninth Edition (2019) of "Best Law Firms," 1,297 ballots were sent to lawyers in the Connecticut region, and 244 firms were nominated. A total of 3,887 Connecticut voters gave feedback on firm work and provided 9,600 individual firm evaluations.

### 2018

For the Eighth Edition (2018) of "Best Law Firms," 1170 ballots were sent to lawyers in the Connecticut region, and 223 firms were nominated. A total of 3,367 Connecticut voters gave feedback on firm work and provided 8,926 individual firm evaluations.

### 2017

For the Seventh Edition (2017) of "Best Law Firms," 1074 ballots were sent to lawyers in the Connecticut region, and 215 firms were nominated. A total of 2,922 Connecticut voters gave feedback on firm work and provided 7,170 individual firm evaluations.

### 2016

For the Sixth Edition (2016) of "Best Law Firms," 651 ballots were sent to lawyers in the Connecticut region, and 217 firms were nominated. A total of 1,899 Connecticut voters gave feedback on firm work and provided 5,907 individual firm evaluations.

### 2015

For the Fifth Edition (2015) of U.S. News - Best Lawyers® "Best Law Firms," 642 ballots were sent to lawyers in the Connecticut region, and 214 firms were nominated. A total of 1,802 Connecticut voters gave feedback on firm work and provided 5,154 individual firm evaluations.
